Dear Donors and Friends:

I became involved with the IAOMS Foundation because I saw, first-hand, the lack of educational opportunities for OMS trainees and young surgeons in some countries. At the IAOMS Foundation, we strive to raise the bar on education through training, fellowships, the International Board Exam, and in the future, research grants.

This year, we sponsored three trainees (from Iraq, Nigeria and Puerto Rico), who participated in the IAOMS Fellowship Program, a comprehensive immersion program in India and China where participants learn from and work alongside expert OMS practitioners and clinicians. Through our Surgeon-to-Surgeon Program, highly experienced surgeons and teachers travelled to emerging countries to train young surgeons, helping them master innovative procedures to advance global care standards.

And with the International Board Exam, which the IAOMS and the Foundation have supported since its inception, we're helping to provide a recognized credential for OMS surgeons, particularly those practicing in emerging countries.

We continue to develop a long-term, strategic plan to grow the Foundation's assets. To strengthen our ability to provide more training programs, we are exploring the diversification of our donor base including expanding the number of participating trainees and younger surgeons, securing more corporate gifts as well as providing a giving experience through Circles of Interest. We will keep you apprised of these developments, including how you can become more involved with the IAOMS Foundation.

Clearly, all of this critical work requires funding – from individuals, other foundations and corporations. We are grateful to the KLS Martin Group for its generous, five-year challenge grant which began in 2014. And to encourage individual giving, we established the Laskin Legacy Society in honor of Dr. Daniel Laskin, one of the pre-eminent OMS surgeons in the world. 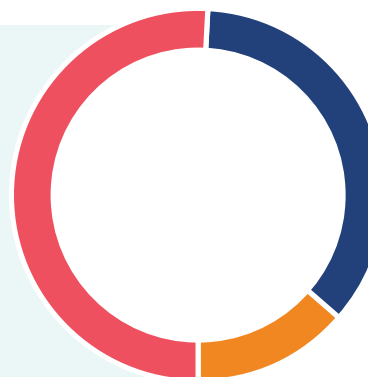
